Samantha Skenandore (Ho-Chunk) is an attorney with Quarles & Brady LLP in Madison, Wisc., and an Associate Justice of the Ho-Chunk Nation's Supreme Court. She began her career in Indian land in the 1990s with the Ho-Chunk Nation's Department of Heritage Preservation. Since 2005, Skenandore has represented Native nations, entities and tribal organizations in legal practice involving real estate, cultural resources preservation, government affairs, tribal code development, economic development, corporate transactions and

litigation. She holds a bachelor's degree from the University of Wisconsin and a J.D. from the University of Denver School of Law. Skenandore joined the ILTF Board of Directors in 2017 and in 2018 was elected chair.

"My involvement in ILTF exists because it is necessary to do my part in preserving, conserving and providing a means to perpetuate tribal existence throughout Indian Country," she said. "I started out volunteering by presenting at ILTF-related conferences on topics involving reacquisition and long-term preservation of ancestral tribal lands. It was through this experience that I learned about ILTF's impact on Indian Country through various programs supporting the return of land to tribes."
